Re: Code of Conduct Complaints against Mayor Greg Dionne

I recently forwarded two statements of account to your attention with the hope that they would be brought forward for consideration and decision by Council on the question of whether the City is prepared to pay or contribute to Mayor Dionne's legal fees pursuant to s. 317(3)(a) of *The Cities Act* recited below:

317(3): A city may pay:

a. The cost of defending a ... proceeding against a member of council ... that claims liability on the part of that person for acts and omissions done or made by the person in good faith in the course of his or her duties;

I believe the precedent may have been established earlier when the City agreed to pay the outstanding account for a sitting member of Council whose qualifications to sit on Council were challenged. In that instance, an application was filed at the Court of King's Bench. We responded and filed a brief of law and a number of affidavits supporting our client's position. The Applicant agreed to pay the Bill of Costs. I believe the City agreed to pay the balance owing.
