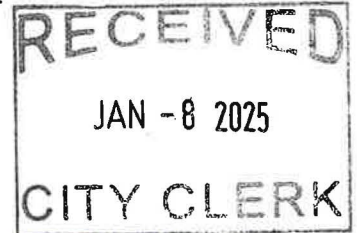

# Northern Area Teachers' Association

January 8, 2025

Good day!

I am writing to you on behalf of the Northern Area Teacher's Association (NATA), which represents 380 plus teachers from the communities of La Loche, Buffalo Narrows, Green Lake, Jan's Bay, Cole Bay, Beauval, Pinehouse Lake, La Ronge, Bear Creek, Sandy Bay, Timber Bay, Weyakwin, Stony Rapids, Sandy Bay and Uranium City. All of which are communities north of Prince Albert. NATA is a teacher local association.

Each year in October, typically the Tuesday-Thursday after Thanksgiving, we host our annual conference in Prince Albert. This has been the practice for at least 20 year plus. Historically, the conference has been held at the Art Hauser Center.

Last year, we changed venues as the Art Hauser no longer met our needs due to the need for break-out session rooms, which meant we rented various boardrooms around the city which complicated things a bit. This past year, our organizers chose Plaza 88 as the venue, which does not have the same amount of parking as the Art Hauser. This meant that we paid \$3,780 to the City of Prince Albert for parking in city owned lots and meters in the area. Some of our members ended up with parking tickets due to parking in the wrong spot, which they paid for, and we reimbursed them.

Plaza 88 has already been booked for the NATA Conference 2025 and once again we will require parking. We would be very interested in receiving a reduction in parking fees, or preferably a waiver of parking fees if possible. The rationale being that we bring quite a bit of business to your local economy through the purchase of hotel rooms, restaurant visits, entertainment venue usage, catering etc.

I would also like to ask that if any member of Council holds the portfolio connected to the Prince Albert Chamber of Commerce, to please share this information with Prince Albert Chamber of Commerce members, in case there is interest in putting their establishments forward as preferred businesses by providing coupons or discounts for educators during this time.

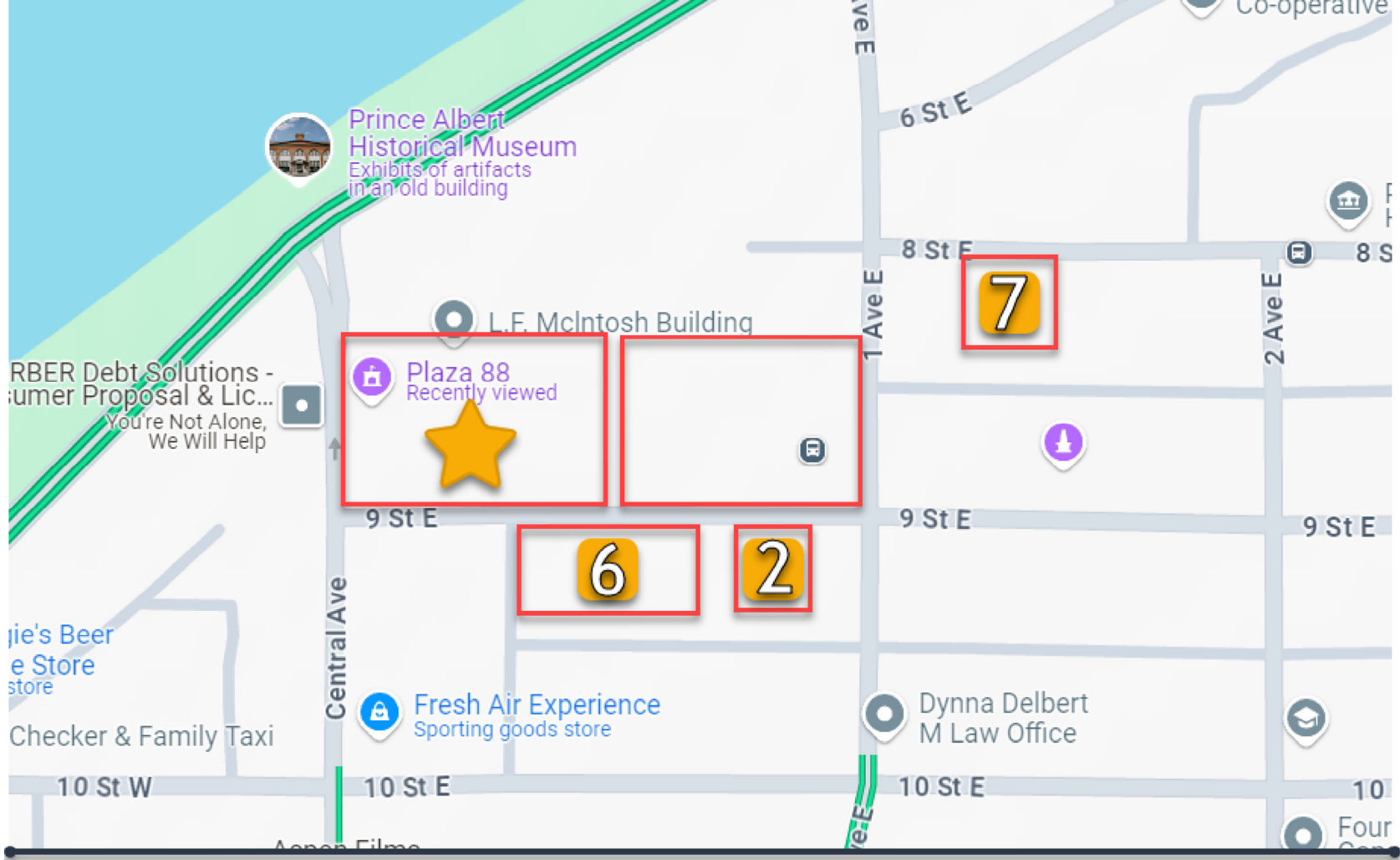
