TITLE: 2024 Police Special Tax Surplus Allocation

RECOMMENDATIONS:

- 1. That the 2024 Police Special Tax Revenue, collected in the amount of \$551,852.33 as per Bylaw No. 5 of 2024, be credited to the Police Service Proactive Policing Reserve to offset the 2024 costs.
- 2. That \$608,489.00 be transferred from the Police Service Proactive Policing Reserve to the Prince Albert Police Service Operating Budget to fund the 2024 costs of the Proactive Policing Unit, as part of the Multi-Year Proactive Policing Strategy.

EXECUTIVE SUMMARY:

The Multi-Year Proactive Policing Strategy for the Prince Albert Police Service was established by City Council, which approved an annual transfer of \$554,000 to the Prince Albert Board of Police Commissioners to support proactive policing efforts. Any unspent funds from this transfer were to be allocated to the Proactive Policing Reserve to fund the six-year strategy. The City has collected \$551,852.33 from the Police Special Tax. That special tax will fund part of the Proactive Policing Strategy costs in 2024. The total cost for 2024 for the Proactive Policing Strategy was \$608,489. This report is recommending that the shortfall in special tax for 2024 to fund the Proactive Policing Strategy be funded from the Proactive Policing Reserve.

BACKGROUND:

A municipality may pass a special tax bylaw and Subsection 278(1) of the *Cities Act* provides that the use of the revenue raised by a special tax must be used for that specific service or purpose stated in the bylaw to be completed within the taxation year. Subsection 278(2) of the *Cities Act* then states that when there is excess revenue generated from the special tax (i.e. actual expenses are less than the actual revenue from the special tax), the City shall give public notice of the use to which it proposes to put the excess revenue. This requirement in subsection 278(2) will allow for transparency between the City and residents as to what their tax dollars are being used for.

Multi-Year Proactive Policing Strategy – Prince Albert Police Service

City Council, at its meeting of May 3, 2021, approved the following motion to establish a Proactive Policing Strategy:

"That the City transfers to the Prince Albert Board of Police Commissioners the funding amount of \$554,000 annually to be directed to the Proactive Policing Strategy for the Prince Albert Police Service; and,

That the unspent funds from the City transfer of \$554,000 annually be forwarded to the Police Service Proactive Policing Reserve created specifically to fund the proposed six (6) year Multi-Year Proactive Policing Strategy for the Prince Albert Police Service."

PROPOSED APPROACH AND RATIONALE:

To fund the Strategy, the attached Bylaw No. 5 of 2024 – Police Special Tax was approved to levy a special tax against all properties listed in the Bylaw that benefits from policing services within the current year. The Bylaw states the estimated cost of the purpose or service is \$554,600, pursuant to the approved Budget.

Attached is a Report from the Police Service Finance Manager to the Prince Albert Board of Police Commissioners outlining the Prince Albert Police Service Proactive Policing Strategy Costs for 2024.

The Board, at its March 18, 2025 Public meeting, approved the following motion:

"That \$608,489.00 be transferred from the Proactive Policing Reserve to the Prince Albert Police Service Operating Budget to fund the 2024 costs of the Proactive Policing Unit, as part of the Multi-Year Proactive Policing Strategy. Further, that the 2024 Police Special Tax Revenue, collected in the amount of \$551,852.00 as per Bylaw No. 10 of 2022, be credited to the Proactive Policing Reserve to offset these costs."

As per the Special Tax Bylaw, when there is excess revenue generated from the special tax (i.e. actual expenses are less than the actual revenue from the special tax), the City shall give public notice of the use to which it proposes to put the excess revenue. For Year 2024, the spending exceeds the revenue generated from the Police Special Tax.

As approved by the Board of Police Commissioners, this report is recommending the same recommendations for approval by Council as follows:

- That the 2024 Police Special Tax Revenue, collected in the amount of \$551,852.33 as per Bylaw No. 5 of 2024, be credited to the Police Service Proactive Policing Reserve to offset the 2024 costs.
- That \$608,489.00 be transferred from the Police Service Proactive Policing Reserve to the Prince Albert Police Service Operating Budget to fund the 2024 costs of the Proactive Policing Unit, as part of the Multi-Year Proactive Policing Strategy.

CONSULTATIONS:

The attached Report from the Police Service Finance Manager was forwarded to the March 18th Prince Albert Board of Police Commissioners regarding the Prince Albert Police Service Proactive Policing Strategy Costs for 2024.
